



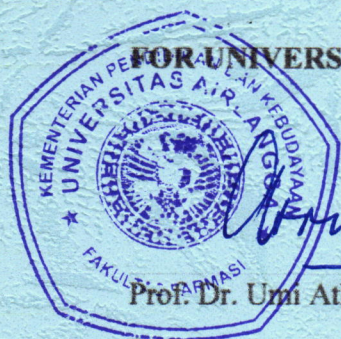
**MEMORANDUM OF AGREEMENT ON ACADEMIC COOPERATION
BETWEEN
FACULTY OF PHARMACY, UNIVERSITAS AIRLANGGA, REPUBLIC OF INDONESIA
AND
FACULTY OF PHARMACEUTICAL SCIENCES,
UBON RATCHATHANI UNIVERSITY, KINGDOM OF THAILAND**

Faculty of Pharmacy, Universitas Airlangga, having an address at Jalan Mulyorejo, Campus C, UNAIR, Surabaya, Republic of Indonesia, represented by Professor Dr. Umi Athiyah, MS, Apt., Dean, and Faculty of Pharmaceutical Sciences, Ubon Ratchathani University, located at 85 Sathonlamark Road, Warin Chamrap District, Ubon Ratchathani Province, Kingdom of Thailand, represented by Dr. Saksit Sripa, Dean (authorized by the President), both universities may be referred to individually as the "Party" and jointly as the "Parties", hereby conclude this Memorandum of Agreement on Academic Cooperation (hereinafter referred to as "this Agreement") to promote academic cooperation.

1. The purpose of this Agreement is to promote cooperation in pharmaceutical education, educational exchange, and scientific research, on the basis of equality and reciprocity and to promote relations and mutual understanding between, Faculty of Pharmacy, Universitas Airlangga, Republic of Indonesia, and Faculty of Pharmaceutical Sciences, Ubon Ratchathani University, Kingdom of Thailand (hereinafter referred to as the "Academic Cooperation").
2. The Parties will pursue the Academic Cooperation as follows:
 - (1) Exchanges of undergraduate and graduate students;
 - (2) Exchanges of visiting scholars, researchers, instructors;
 - (3) Joint research projects in the field(s) of pharmaceutical sciences;
 - (4) Participation in international conferences, seminars, symposia, workshops and other activities agreed by both Parties
3. Details of any academic cooperation in which there are relevant costs, incomes, or ownerships of co-created innovations resulting from this Memorandum of Agreement will be negotiated and determined in the form of an Addendum to this Memorandum of Agreement.
4. This Agreement is not intended to be legally binding. Nothing, therefore, shall diminish the full autonomy of either Party, nor shall any constraints be imposed by either Party upon the other Party in carrying out this Agreement.

5. This Agreement shall come into effect on the date when the representatives of the Parties affix their signatures to this Agreement and shall be valid for a period of five (5) years. This Agreement may be renewed, revised or modified after discussion by representatives of both Parties. This Agreement shall be terminated by providing a six (6) months' prior written notice by of either the Party.

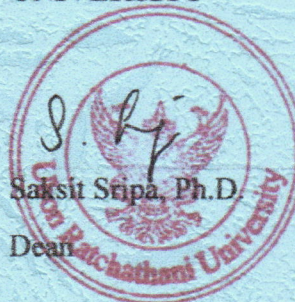
