

**AGREEMENT FOR ACADEMIC EXCHANGE AND COOPERATION
BETWEEN
FACULTY OF PHARMACEUTICAL SCIENCES,
UBON RATCHATHANI UNIVERSITY, KINGDOM OF THAILAND
AND**

MARSHALL UNIVERSITY SCHOOL OF PHARMACY, UNITED STATES OF AMERICA

This Memorandum of Understanding (MOU) describes the potential for collaboration between the faculty of Marshall University School of Pharmacy (MUSOP) and the Faculty of Pharmaceutical Sciences at Ubon Ratchathani University (UBU). The faculty of MUSOP and UBU agree that research collaborations, as well as student and faculty exchanges, are mutually beneficial. The areas of cooperation may include, subject to mutual consent, any desirable and feasible activity that would further the goals of each institution. Such interaction may include a variety of joint academic and education activities such as:

- a) Joint research projects and publications, including work by undergraduate, graduate, and post-doctoral students at the partner institutions;
- b) faculty and student exchanges;
- c) reciprocal placement of students in rotations, internships and co-ops, when possible;
- d) joint conferences and workshops;
- e) team-taught courses, including online courses;
- f) visits by faculty, professional staff, and students; and
- g) other activities mutually agreed upon by both institutions.

SCOPE OF COLLABORATION

- 1) Any specific activity to be developed under this MOU shall be detailed in a subsequent agreement, signed by each institution's authorized signatory, which will describe the scope of the proposed activity, intended outcomes, budget, and responsible departments or individuals. All activities shall be subject to the availability of funds and the approval of each institution's authorized representatives. This MOU does not commit or imply any financial obligations on either institution.
- 2) This MOU shall be effective for five (5) years upon the last date of signing by the representatives of both institutions. Any activities in progress at the time of termination shall be permitted to conclude as planned unless otherwise agreed in writing. A joint evaluation of the MOU will be initiated by the designated representatives six (6) months

before the expiration date. Following the evaluation, the MOU may be renewed and resigned for an additional five (5) year period.

- 3) Amendments to this MOU must be made, in writing, and approved by the authorized signatories.
- 4) The parties agree not to discriminate on the basis of religion, race, creed, national or ethnic origin, sex, age, disability, political affiliation, sexual orientation, disability or status as a veteran.
- 5) All formal collaborations emerging from this MOU will conform to applicable regulations, laws, and institutional policies.
- 6) This MOU may be amended at any time by mutual written consent and may be terminated by giving six (6) months written notice to either institution before the desired termination date. Provided that, any termination of this MOU will not impact any agreements reached under Paragraph 1, above.
- 7) This MOU shall be written in English, and signed in duplicate with each party receiving an original.
